KNOW ALL MEN BY THESE PRESENTS;

That we Louis Winkler, H. F. Jorgans, P. W. Johnson, F. T. Mathias, and L. L. Burtenshaw, of the <sup>town of Council</sup> County of Washington, ~~in the State of Idaho~~, are desirous of forming a private Corporation under the laws of the State of Idaho, and to that end do hereby Certify

( First )

That the name of this Corporation, shall be, and the name by which it shall be known is THE COUNCIL AND THUNDER MOUNTAIN, PROSPECTING AND DEVELOPMENT COMPANY ( Limited. )

( Second )

That the purposes for which this Corporation is formed is ( a ) to prospect locate and develop mines, both quartz and placer ( b ) to buy sell and operate mines ( c ) to locate own and control water rights for mining and domestic purposes, and to acquire the same either by purchase location or otherwise, ( d ) to locate own and control saw mills, and to locate water for the same, ( e ) to locate mill sites town sites, and smelter sites, and to acquire water rights, either by location or otherwise to successfully operate the same, ( f ) and to deal generally in mines and mining property.

( Third. )

That the place where its principal business is to be transacted, is COUNCIL WASHINGTON COUNTY, <sup>State</sup> IDAHO.
