ARTICLE I

The name of this corporation is and shall be:

GLOBAL OPERATING CO.

ARTICLE II

The purpose or purposes for which this corporation is formed are:

- a. Primarily to engage in the specific business of mining and the production of ores and metals.
- b. Generally to engage in the business of acquiring mineral rights to lands and developing and mining such mineral rights or lands in the production of ores and metals and the processing of such ores and metals.
- c. To generally engage in the business related or unrelated to those described in clauses (a) and (b) of this Article Second; and from time to time authorized or approved by the Board of Directors of this corporation.
- d. To act as principal, agent, partner, joint venturer or in any other legal capacity in any transaction or lawful business act or activity for which corporations may be organized and incorporated under the "Idaho Business Corporation Act" as amended.

- e. To do business anywhere in the world.
- f. To have and exercise all rights and powers from time to time granted a corporation by law.

The above purpose clauses shall not be limited by reference to or inference from one another, but each such purpose clause shall be construed as a separate statement conferring independent purpose upon the corporation.

ARTICLE III

The corporate existence of this corporation shall be perpetual.
