

RESTATED ARTICLES OF INCORPORATION
OF
POTLATCH TELEPHONE CO., INC.

Pursuant to the provisions of Section 30-1-64 of the Idaho Business Corporation Act, the undersigned corporation, pursuant to a resolution duly adopted by its board of directors, hereby adopts the following Restated Articles of Incorporation:

ARTICLE I. The name of the corporation is Potlatch Telephone Co., Inc.

ARTICLE II. The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III. The duration of the corporation is perpetual existence.

ARTICLE IV. The location and address of the registered office of the corporation in the State of Idaho, is Kendrick, Latah County, Idaho.

ARTICLE V. The total authorized number of par value shares is One Thousand (1,000) with a par value of one hundred dollars (\$100.00) per

share. The aggregate par value of the total authorized number of par value shares is One Hundred Thousand Dollars (\$100,000.00).

ARTICLE VI. The stock of the corporation consists of One Thousand (1,000) shares of common stock, all of the same class, with a par value of One Hundred Dollars (\$100.00) per share. At all meetings of the stockholders and at all elections of directors every stockholder of record shall be entitled to one vote for each share of stock standing in his name of the books of the corporation.

ARTICLE VII. The names and post office address of each of the incorporators and the number of shares for which each subscribes is as follows:
