ARTICLES OF INCORPORATION

OF

IDAHO PARENTS UNLIMITED FOR THE HANDICAPPED, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a non-profit corporation under the laws of the state of Idaho, and we do hereby certify, declare, and adopt the following articles of incorporation:

ARTICLE I.

The name of this corporation shall be "IDAHO PARENTS UN-LIMITED FOR THE HANDICAPPED, INC."

ARTICLE II.

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III.

The location of the registered office of this corporation shall be Nampa, Canyon County, State of Idaho, and the address of the registered office of this corporation shall be 2200 E. Maryland, Nampa, Idaho 83651.

ARTICLE IV.

The nature of the business and the object and purposes of this corporation shall be:

To obtain better services for all handicapped, regardless of race, religion or ability to pay.

To advise and aid parents in the solution of their problems and to coordinate their efforts and activities, through parent training.

To develop a better understanding of the problems of the handicapped by the public.

To cooperate with all public, private, and religious agencies, and with professional groups in the furtherance of these ends.

To do each and everything necessary, suitable, useful or advisable for the accomplishment of any one or more of the objectives of said corporation, or which shall, at any time appear to be conducive to or expedient for the benefit of said corporation in connection therewith.

This corporation is organized exclusively for charitable or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE V.

The membership of this corporation shall be open to all parents, relatives, and guardians, including foster parents, of handicapped children, and any other persons or organizations to the purposes of the corporation who reside in the State of Idaho.

Membership shall be divided into three categories:

- 1. Paid Membership
- 2. Open Membership
- 3. Organizational Membership

Any person may request an I.P.U.L. Membership Form and upon completion of said form, shall be entitled to a membership certificate, to be designated by the Membership Committee after said form has been reviewed and approved by said committee.

The rights and interest of all members shall be divided in the following manner:

Only paid memberships have voting privileges and shall be allowed to hold an office in this organization.

ARTICLE VI.

In furtherance, and not in limitation, the powers conferred by statute, the Board of Directors is expressly authorized:

In general, shall be responsible for overseeing the function of the organization by:

Developing programs to accomplish the goals of committees.

Participating in the selection of new committees.

Supervising of committee members and the Project Director of said corporation.

ARTICLE VII.

Members of this corporation shall not be individually liable for the debts of said corporation.

ARTICLE VIII.

ARTICLE IX.

These articles may be amended by a two-thirds vote of the members of said corporation present and voting at any regular or special meeting called for that purpose.

ARTICLE X.

Upon dissolution or other termination of the corporation, no member shall be entitled to any distribution or division of the remaining property or its proceeds, and the balance of all money and other property received by the corporation shall be used or distributed to more than one non-profit fund, foundation or corporation, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE XI.

The initial registered agent for this coporation shall be Sandra Scheffert. The address for the initial registered office and the initial registered agent is 2200 E. Maryland, Nampa, Idaho 83651.

We the undersigned, for the purpose of forming a corporation for the purposes hereinbefore set forth, have hereunto set our hands and seals this the day of January, 1985, and each of us agree to act as a director of said corporation until his or her successor is elected or appointed in the manner provided by the By-Laws of this corporation.
