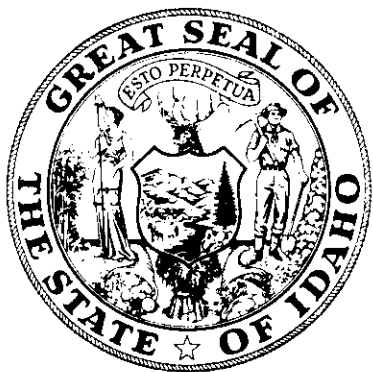

5. **DISTRIBUTION OF ASSETS:** All of the remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective holdings.

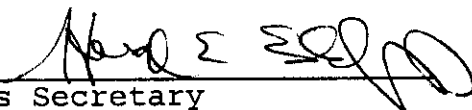
