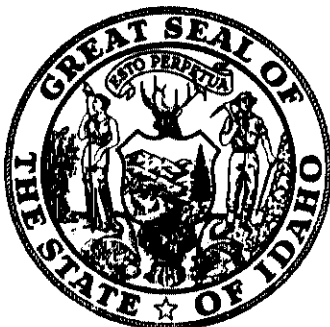
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is MAGIC VALLEY BREEDING & CONSULTING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are for artificial breeding, semen sales, dairy management consulting plus any other thing for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is 609 9th Avenue East, Gooding, Idaho 83330. The name of its initial registered agent at such address is Gilbert D. McDougal.
