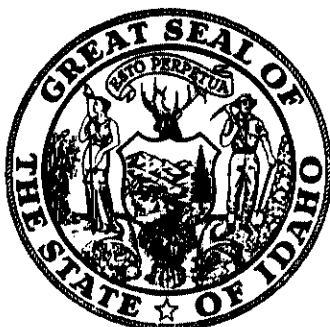

The INTERNATIONAL FEDERATION OF SLEDDOG SPORTS, INC., a non-profit corporation ("Corporation") organized and existing pursuant to the Idaho Non-Profit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act") in accordance with Articles of Incorporation for the Corporation filed with and approved by the Secretary of State of the State of Idaho on October 21, 1992, adopts the following Articles of Amendment for the Corporation pursuant to Section 30-327, Idaho Code.

SECRETARY OF STATE

1. NAME:

The name of the corporation is INTERNATIONAL FEDERATION OF SLEDDOG SPORTS, INC., also known as "IFSS".

2. AMENDMENTS:

Articles 4 and 10 are amended to read as follows:

4. PURPOSES:

The purpose for which the Corporation is organized and will be operated is to foster international sleddog sports competition and the prevention of cruelty to animals within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1987, as amended from time to time, primarily by conducting international sleddog sports events and by developing, supporting and educating its members for such competition.

10. DISTRIBUTION ON DISSOLUTION:

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of this corporation, distribute all the assets of the

corporation consistent with the purposes of the corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine.

Except for the amendments stated above, all other Articles of the Corporation's Articles of Incorporation remain unchanged and are hereby reaffirmed and restated.


3. **ADOPTION BY CONSENT:**
