

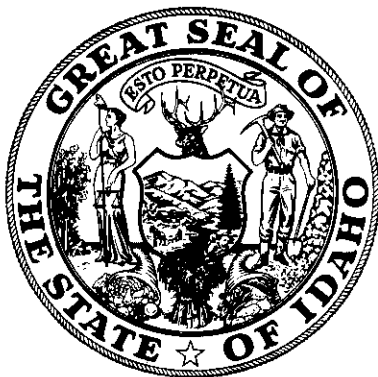
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

DIVERSIFIED KNIE INVESTMENTS, INC.

FIRST. The name of this corporation is DIVERSIFIED KNIE INVESTMENTS, INC.

SECOND. Its registered office in the State of Idaho is to be located at Box 26278, Route 2, Wilder, Idaho, 83676, County of Canyon.

THIRD. The purpose of this corporation is to engage in land and mineral investment and development projects, and in any lawful acts for which corporations may be organized under the general corporation laws of Idaho. The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.

FOURTH. The amount of the total authorized capital stock of this corporation is 100 common shares of no par value.

FIFTH. The Directors shall have the power to make and to alter or amend the By-Laws; to fix the amount to be reserved as working capital, and to authorize and cause to be executed, mortgages and liens without limit as to the amount, upon the property and franchise of the Corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the Directors shall have the authority to dispose, in any manner, of the whole property of this corporation.

The Directors shall have power to hold their meetings and keep the books, documents and papers of the Corporation outside of the State of Idaho, at such places as may be designated by the Directors.

SIXTH. The address of the initial registered office is Box 26278 Route 2, Wilder, Idaho 83676. The name of the initial registered agent at this address is Mr. Lonnie D. Knie.

SEVENTH. The directors are the same three people as the incorporators. Their names and addresses are as follows:

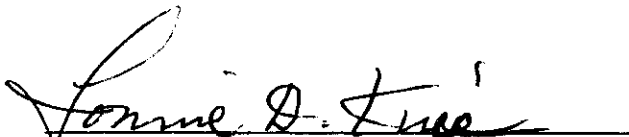

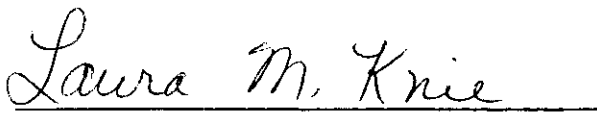

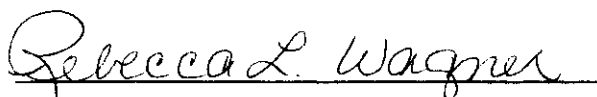
