ARTICLES OF INCORPORATION
OF
GEM STATE TRUSS & COMPONENTS, INC.

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GEM STATE TRUSS & COMPONENTS, INC.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: to produce, manufacture and sell trusses and related building products and construction supplies and to engage in any or all activities associated therewith or incidental thereto, and to engage in any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act..
