There are no remaining assets or property of J Bar C, Inc. to be distributed.



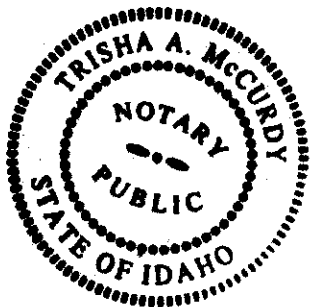


