ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

VERN'S BODY SHOP, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is VERN'S BODY SHOP, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the Board of Directors of the corporation on July 18, 1990, in the manner prescribed by the Idaho Business Corporation Act:
