GALLAFENT and SUSAN KATSILOMETES, citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end we do hereby certify:

I

The name of this corporation shall be: G AND S PROPERTIES, INC.

II

The period of existence of this corporation shall be perpetual.

The purpose for which the corporation is formed is to own, operate and manage motel and other rental real property.
