

Lutheran Church Extension Fund-Missouri Synod

This Corporation is formed for religious, educational and charitable purposes, namely to provide financial resources and related services for ministry, witness and outreach of The Lutheran Church-Missouri Synod ("The Synod). In so doing it shall raise funds primarily through the issuance of corporate notes and other debt instruments. The assets of the Corporation shall be used exclusively for the following:

- a. To provide financing and services for the acquisition of sites; the construction of facilities; the purchase of buildings and equipment; operating expenses; professional church worker; and other purposes approved by the Board of Directors of the Corporation consistent with the ministry and mission of the Synod under policies approved by the Board of Directors of the Synod.
- b. To provide financing for the operations of the Corporation and for distribution of operating results to its member Districts, congregations and corporate Synod, as determined by the Board of Directors of the Corporation.
