WHEREAS a Petition to Incorporate the community of Dover into the City of Dover, Idaho, was duly filed with the Board of County Commissioners of Bonner County, Idaho, pursuant to the provisions of Idaho Code, Title 50, Chapter 1, and

WHEREAS the Clerk of the Board has ascertained that the Petition met the requirements of I.C. 50-101 and I.C. 50-102, and

WHEREAS the Clerk of the Board cause a Notice of Public Hearing to be published on July 12 and July 19, 1988, pursuant to I.C. 50-102, and

WHEREAS said hearing aforesaid was had on July 26, 1988, at the hour of 11:00 A.M., and

WHEREAS no opposition was registered, and good cause appearing therefore,

IT IS HEREBY PROCLAIMED that the community of Dover, Idaho, be and is hereby incorporated as the City of Dover, State of Idaho, with boundaries as herein defined, to-wit:

Commencing at the East Quarter corner of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence West 1590' to the True Point of Beginning; Thence South 1715'+- to the South boundary of Highway #2; Thence West 400'+- to the Northwest corner of Lot 3 of Dover Tracts; Thence South along the East boundary of Lot 3 and 4 of Dover Tracts and beyond a distance of 420'+- to the shores of Lake Pend Oreille; Thence South and Easterly along the shores of Pend Oreille to its intersection with the North-South centerline of Section 31, Township 57 North, Range 2 West, Boise Meridian; Thence North along said centerline of Section 31 to the South boundary of Highway #2; Thence Easterly along the South boundary of Highway #2 to the Southwest corner of Section 29, Township 57 North, Range 2 West, Boise Meridian. Thence North to the West Quarter corner of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence Westerly to the point of beginning.

BE IT FURTHER PROCLAIMED that Bill O'Donnell is hereby appointed Mayor thereof, and Loretta Boyle, Peggy Buerge, Craig Hofmeister and Margaret Becker are hereby appointed as the four member City Council to serve in such capacity upon taking the oath of office until the next general city election succeeding their appointment and until their successors are elected and qualified, and

BE IT FURTHER ORDERED that the Clerk shall certify a copy of this Resolution and forward the same to the Office of the Secretary of State, Boise, Idaho.

Thence North to the West Quarter corner of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence Easterly to the point of beginning.

BE IT FURTHER PROCLAIMED that BILL O'DONNELL is hereby appointed Mayor thereof, and LORETTA BOYLE, PEGGY BUERGE, CRAIG HOFMEISTER and MARGARET BECKER are hereby appointed as the four member City Council to serve in such capacity upon taking the oath of office until the next general city election succeeding their appoint-ment and until their successors are elected and qualified, and
