# ARTICLES OF INCORPORATION

The undersigned, a person of the age of more than eighteen years, acting as the incorporator of the above corporation, does hereby sign and acknowledge the Articles of Incorporation in duplicate originals, and does declare and set forth as follows:

# ARTICLE I

The name of the corporation shall be B. D. I., Inc.

# ARTICLE II

The period of duration of the corporation shall be perpetual.

# ARTICLE III

The purposes for which the corporation is formed are:

- 1. To engage in the manufacturing of brake parts for trucks and other motor vehicles; to acquire, own, use, dispose of and operate any and all equipment necessary and incidental to the operation of the above business.
- 2. To conduct and carry on its business or any part thereof, and to have one or more offices and to exercise all or any of its corporate powers and rights in the State of Idaho and in the various states, territories, colonies and dependencies of the United States, in the District of Columbia and all or any foreign countries or country.
- 3. To engage in any kind of business authorized or permitted by the general incorporation laws of the State of Idaho.

ARTICLES OF INCORPORATION - 1

4. To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinabove set forth, either along or in association with the corporations, firms or individuals, and to do every act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers or any part or parts thereof; provided, however, that the same be not inconsistent with the laws under which this corporation is organized.

#### ARTICLE IV

The capital stock of this corporation shall consist of Twenty-five thousand (25,000) shares of common stock, all at no par value.

#### ARTICLE V

The capital stock of this corporation shall be one class only, and all shares shall have equal rights and voting powers and there shall be no preferences.

#### ARTICLE VI
