

ARTICLES OF INCORPORATION OF THE KAMPA FOUNDRY AND MACHINE WORKS, LTD.

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation, under the laws of the State of Idaho.

AND WE CERTIFY,

First. That the name of said corporation is the KAMPA FOUNDRY AND MACHINE WORKS., LIMITED.

Second. That the purposes for which it is formed are:

To conduct a general foundry and machine works, to manufacture and operate machinery of all kinds including quartz mills and reduction works; to acquire and dispose of real estate, including mines and mining claims and also all other kinds of property which may be necessary to successfully conduct the said business.

Third. That the place where its principal business is to be transacted shall be Kampa, in the County of Canyon, State of Idaho.

Fourth. That the term for which it is to exist is fifty years, from and after the date of its incorporation.

Fifth. That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:
