KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, residents of the United States of America, have this day veluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Washington, AND WE HEREBY CERTIFY:

ARTICLE 1.

That the name of this corporation is, and shall be Toltec Mining Company.

ARTICLE 2.

That the purposes for which this corporation is formed are, to acquire, hold, plat into city and town lots, sell, lease, buy and mortgage lands, real estate and mill property in the United States of , America and the Province of British Columbia, Canada, and Mexico; to work, operate. buy, sell, purchase, lease, locate, acquire, procure, hold and deal in mines, metals, mineral claims and locations of every kind and description within the United States of America and the Province of British Columbia, Canada, and Mexico; to carry on and conduct a general mining, milling, smelting and reduction business in the United States of America and the Province of British Columbia, Canada and Mexico; to purchase, acquire, hold, erect and operate electric light and power plants for the purpose of mining, treating and transportation of ore, and for the purpose of furnishing light and heat and creating power for all purposes in the United States of America and the province of British Columbia, Canada and Mexico; to buy, bond, sell, build, hold, operate and conduct railroads, ferries, tramways and other means of transportation for the transporting of goods, merchandise, timber, lumber, shingles, ore, mining and other material in the United States of America and the Brovince of British Columbia, Canada and Mexico; to acquire. lease and operate water-rights and flumes for the purpose of mining and treating ore, and running and operating machinery and transporting timber, lumber, shingles, goofs and merchandise and running and
