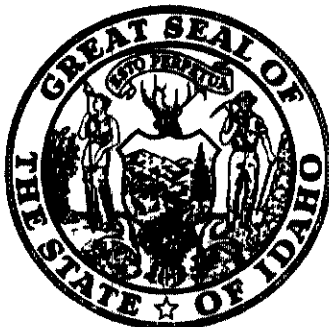

ARTICLES OF INCORPORATION

The undersigned, being natural persons of full age citizens of the Unites States of America and residents of the State of Idaho, acting as incorporators of a corporation under the Idaho Business Corporation Act, have voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and do hereby and herein adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Cochran Farms, Inc.

ARTICLE II

The purposes for which the corporation is organized are:

1. To engage in a farming activity.
2. To buy or sell agricultural products or services including agricultural guidance systems.
3. To apply for, receive and hold all licenses that may be necessary or required from any licensing agency, Federal, State, municipal or foreign, for conducting any business in which the corporation may hereafter be engaged.
