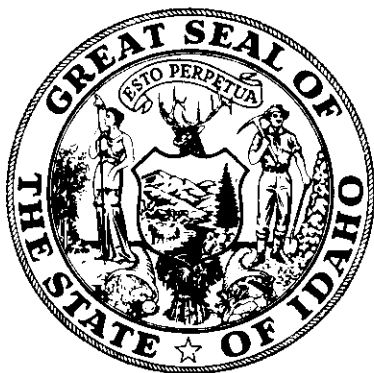

INCORPORATION OF STUDIOS 310  
The following Article of Amendment of the Articles of Incorporation of STUDIOS 310, A Nonprofit Corporation was adopted by a majority of the members at a regularly scheduled meeting on June 21, 1986.

The amendment segment to be changed is Article V.

The text of the article to be changed is:

In the event of the dissolution of the association or the winding up of its affairs, the association's property shall not be conveyed or distributed to any individual or organization created or operated for profit, but shall be conveyed or distributed only to an organization or to organizations created and operated for nonprofit purposes similar to those for the association.

The text of Article V should be amended by a further explanatory sentence and should read:

In the event of the dissolution of the association or the winding up of its affairs, the association's property shall not be conveyed or distributed to any individual or organization created or operated for profit, but shall be conveyed or distributed only to an organization or to organizations created and operated for nonprofit purposes similar to those for the association. Further, the foundation or association must have established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.




