RE: Use of the Word "Bank" in Company Name in Idaho

Dear Ms. Blitman:

The Idaho Department of Finance (Department) received an email from you on February 6, 2024, requesting approval to register the entity "Kuna Food Bank, Inc." with the Idaho Secretary of State. You stated that Kuna Food Bank is currently a dba of the entity Alliance Serving Kuna, Inc., which has caused some confusion, so you are seeking to operate the food bank through this new separate business entity.

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word "bank," "banker," or a word or words of similar import, unless the person holds a banking charter. The Director of the Department may grant a waiver to allow the use of the word "bank," "banker," or words of similar import in certain circumstances. The waiver may be granted if:

- (a) The person is not engaged in banking or trust business;
- (b) The name or title used is not likely to deceive or mislead an individual to believe that the person is engaged in banking or trust business;
- (c) The name or title, or a name or title similar to it, is not already used by another person doing business in this state; and
- (d) The name or title does not suggest or imply that the person is engaged in unlawful conduct.

Based on the information you have provided, it appears that the four factors set forth above are met. As delegated by the Director, I hereby grant a waiver to register and use the business entity Kuna Food Bank, Inc., in accordance with Idaho Code § 26-1202. Please be advised that if changes in circumstances occur, this waiver may be retracted.
