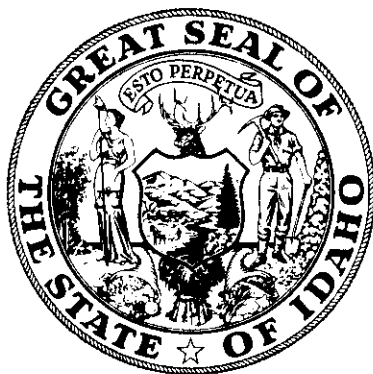

ARTICLES OF INCORPORATION  
OF  
BIRTHRIGHT OF COEUR D'ALENE, INC.

The undersigned, citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Idaho, do hereby certify:

1. The name of the Corporation is: BIRTHRIGHT OF COEUR D'ALENE, INC.
2. The place in this state where the principal office of the Corporation is to be located is the City of Coeur d'Alene, Idaho, Kootenai County, (Roosevelt Bldg. 307, 105 Wallace, Coeur d'Alene, Idaho).
3. The specific purpose of this corporation is to establish a pregnancy crises center organized to help pregnant mothers carry their children to term.

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

4. There shall be one class of membership in the Corporation; each shall pay dues of \$1.00; each member shall be participating in the program and shall have one vote.

5. The period of duration of the Corporation is Perpetual.
6. The RESIGTERED AGENT of the Corporation and her address is:

8. The initial Board of Directors of this Corporation shall consist of 4 individuals, and their names and addresses are:  
TRUDY BEAMER, 9329 Government Way, Hayden Lake, ID 83835  
DENISE FABER, 1900 A 13th Street, Coeur d'Alene, ID 83814  
JENNY HARMS, of Hayden Lake, ID 83835  
RHONDA SAND, W. 600 Hubbard, Coeur d'Alene, ID 83814
9. This Corporation shall have all of the powers conferred to corporations of its kind by the laws and statutes of the State of Idaho.
10. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

11. Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

12. This Corporation shall have all of the powers conferred to Corporations of its kind by the Laws and Statutes of the State of Idaho.

THE UNDERSIGNED, being the incorporators hereinbefore named, for the purposes of forming a corporation to do business both within and without the State of Idaho and in pursuance of the Idaho Nonprofit Corporation Act, do make and file this ARTICLE OF INCORPORATION hereby declaring and certifying that the facts herein stated are true and accordingly have hereunto set our hands this 20 day of January, 1984.
