know all MEN BY THESE PRESENTS: That we, the undersigned, being of legal age, citizens and residents of the United States, for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho relating to private corporations, have this day voluntarily associated ourselves together and hereby agree as follows:

# ARTICLE I.

The name of the corporation shall be DON'S SERVICE STATION EQUIPMENT, INC.

# ARTICLE II.

This corporation shall have perpetual existence, unless the same is sooner dissolved or disincorporated pursuant to law.

#### ARTICLE III.

Said corporation is organized at, and the place of its principal office and business shall be 800 Pescadero Place, Idaho Falls, Idaho 83404, but branch places of business, each complete in itself for the conducting and carrying on of any part of the business of the corporation, or the whole thereof, may be established at other places, whether within or without the state of Idaho, or the United States of America. The registered agent of said corporation is Kevin Tew, 800 Pescadero Place, Idaho Falls, Idaho 83404.

# ARTICLE IV.

The amount of the capital stock of this corporation shall be \$5,000.00 divided into 500 shares. The majority of the shares will initially remain as treasury stock.

# ARTICLE V.

The names and post office addresses of the incorporators, each of whom have subscribed to one or more share of stock are:

#### ARTICLE VI.

The persons who are to serve as directors until the first annual meeting of shareholders, or until their successors be elected and qualified, are:

The initial Board of Directors shall consist of two persons and the Board of Directors shall always consist of two or more persons.

#### ARTICLE VII.

The purposes and objects for which this corporation is formed shall be:

(1) To engage in the business of purchasing, acquiring, owning, leasing, selling, transferring, encumbering and generally

dealing in repairing, renovating and servicing all types of service station equipment and any parts or accessories used in connection therewith; to engage in the retail and wholesale sale of lubrication equipment, of all kinds and descriptions.

- (2) To engage in the business of buying and selling, both at wholesale and retail, and of distributing as a wholesale jobber, broker or agent, all types and kinds of automotive and service station equipment and accessories.
- (3) To establish and conduct a wholesale or retail store or stores for the sale, distribution, repair, maintenance and servicing of service station equipment, petroleum supplies and equipment and any other matters related thereto; to establish and provide such facilities as may be desirable and necessary or incidental to the carrying on of such purposes.
- (4) To underwrite, subscribe for, buy, sell, pledge, mortgage, hold, or otherwise deal in stocks, bonds, obligations or securities of any private or public corporation, government or municipality, trusts, syndicates, partnerships or individuals, and to do any other act or thing permitted by law for the preservation, protection, improvement or enhancement of the value of such shares of stock, bonds, securities, or other obligations including the right to vote thereon.
- (5) In general, to purchase, hold, own and sell real and personal property or any interest therein; to execute notes and security interests therefore.
  - (6) For any and all other lawful purpose or purposes.

# ARTICLE VIII.

All stock of the corporation not subscribed for shall remain in the treasury as treasury stock, and may be sold and issued by the corporation at such times and for such purposes and upon such terms and conditions as the Board of Directors may determine, including the power and authority to issue said stock for consideration other than cash.

#### ARTICLE IX.

The private property of the stockholders of this corporation shall not be liable for the debts of the corporation.

#### ARTICLE X.

The power to repeal and amend Bylaws and adopt new Bylaws is hereby conferred upon the Board of Directors, as well as upon the shareholders, to be exercised by such vote of such directors, or of the allotted shares, as the case may be, not less, however, than a majority thereof, as may be fixed by the Bylaws.

# ARTICLE XI.

All or any meetings of the stockholders or of the Board of Directors may be held within or without the State of Idaho.
