- e. To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, warrants, bonds, debentures, and other negotiable instruments.
- f. To make all lawful contracts, and to do other things necessary, proper and requisite to carry into effect the objects or purposes aforesaid, and to do all and singular the things and have the powers provided by the laws of the State of Idaho under which this corporation is organized.
- g. To engage in the business of selling, servicing and otherwise dealing in insurance of any type or kind.
