AMENDMENT OF ARTICLES OF INCORPORATION

OF

REXBURG LIVESTOCK AUCTION, INC.

THIS IS TO CERTIFY:

First: That the board of directors of Rexburg Livestock Auction, Inc., a corporation having its principal office in Rexburg, Madison County, Idaho, at a meeting duly called and held on April 9th, 1949, adopted, by the affirmative vote of more than two-thirds of the directors present at such meeting the following resolution:

1. That it is advisable to amend Article V of the Articles of Incorporation of said corporation to read as follows:

"The authorized capital stock of Rexburg Livestock Auction, Inc., be increased from 500 shares of the par value of \$100.00 each to 1000 shares of the par value of \$100.00 each so that the authorized capital stock of said corporation shall hereafter be \$100,000 instead of \$50,000 as heretofore.

2. That said proposed amendment shall be submitted for action thereon by the stockholders at a special meeting thereof to be held on May 11, 1949, at Rexburg, Idaho, at 8 o'clock P. M., and that notice of the time, place and purposes of such meeting be given in accordance with sections 29-145, subdivision #6, and Subdivision #4 of Section 29-132 Idaho Code Annotated.

Second: That the special meeting of the stockholders of said corporation was held May 11, 1949, pursuant to notice given in accordance with subdivision #4, section 29-132, and subdivision #6, section 29-145, Idaho Code Annotated, and at said meeting the stockholders by the affirmative vote ^{of the holders} /of more than two-thirds of the voting power of all share holders duly adopted the amendment to the Articles of Incorporation advised and approved by the board of directors aforesaid.
