The undersigned, acting as incorporators under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

Ι

The name of the corporation is Three Blind Mice, Inc.

The period of the duration of the corporation is perpetuity.

III

The purpose for which the corporation is organized is to provide good quality day care for Latah County, Idaho, to provide good quality preschool for the children enrolled and to provide good nutrition and rest during the day.

Provisions for the regulation of the Internal Affairs of the corporation, including provisions for the distribution of assets on disillusion or final liquidation are: There shall be no profit bearing shares during the corporation's existence. In the event of disillusion any assets shall be made as a donation to any non-profit community organization meeting

501(c)(3) exempt status which preferably promotes child care.
