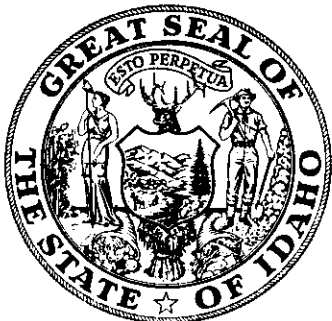

Pursuant to the provisions of Section 30-3-112 of the Idaho Nonprofit Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is NEEWAHLU CAMP FIRE, INC.
2. The dissolution was authorized by the Members and directors on May 1, 1995.
3. The dissolution was approved by a sufficient vote of the Board of Directors.
4. The Corporation has one (1) class of Members and there are nine (9) member-ships outstanding, all of which are entitled to vote.

The number of votes cast in favor of the dissolution was nine (9), and the number of votes cast against the dissolution was zero (0). The number of votes cast in favor of the dissolution was sufficient for approval.
