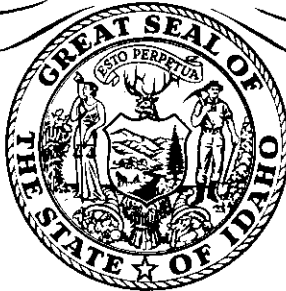

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

FIRST BAPTIST CHURCH OF NORLAND, IDAHO, INC.

was filed in the office of the Secretary of State on the **Fourteenth** day of **December** A. D. One Thousand Nine Hundred **Fifty-nine** and is duly recorded on Film No. **109** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **fifty years** from the date hereof, with its registered office in this State located at **Rupert,** in the County of **Minidoka,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

KNCW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby certify:

1. That the name of the corporation is the First Baptist Church of Norland, Idaho, Inc., and its registered Post Office address shall be Route Number Three, Rupert, Idaho.

2. That the purpose for which it is formed is to acquire and own such real and personal property as may be necessary and convenient for such association in conducting and maintaining religious services, and disposing of same as it may hereafter determine.

3. That the place where its principle business is to be transacted shall be Route Three, Rupert, Minidoka County, Idaho.

4. That the term of the existence of the said corporation shall be fifty years.

5. That the number of its trustees shall be five, and that the names of said trustees as elected for the first year are as follows:

6. That this corporation is a membership corporation without capital stock and the members of the corporation shall consist of all those who are recognized in good standing of the church.

7. That on the 29th day of October, 1959, at Norland, Idaho an election for the trustees of the corporation was held, and at such election a majority of the members of said church were present and voted; that the result of said election was the election of the trustees specified in paragraph five hereof; that at this same meeting of said church said trustees were instructed to form an incorporation under the laws of the State of Idaho, in furtherance of the objects for which the church is founded.

8. That prior to holding said election notice of the same was given by publishing said notice for two weeks in two issues of the Minidoka

County News a newspaper published weekly in the county where said election was held and by posting a like notice in a conspicuous place on the building where such election was held for two weeks prior to the time of said election.
