KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned persons, all of whom are of full age, and at least two-thirds of whom are citizens of the United States of America, do associate ourselves together for the purpose of forming this non-profit cooperative association, and in compliance with the laws and statutes of the State of Idaho, and in particular Chapter 10, Title 30, I.C., do certify and declare as follows:

The name of this association shall NAME OF ASSOCIATION be "IDAHOANS FOR AL DERR, INC." and the location and post office in the State of Idaho shall be 1900 Main Street, Boise, Ada County, Idaho.

DURATION

This association shall expire on

December 31, 1958.

This association shall have no NO CAPITAL STOCK capital stock, but shall issue membership certificates only. Each membership in this association shall be equal with all other members and no member can have or acquire a greater interest therein than any other member. Membership certificates may not be assigned so that the transferee thereof can become a member of this association except by resolution of the Board of Directors and under such regulation as the By-Laws may prescribe.

NUMBER AND QUALIFICATIONS OF MEMBERS There shall be no limit upon the membership of this association

except that each membership admission fee shall be at least One Dollar (\$1.00), but nothing herein contained shall prevent any member or contributor to this association from giving or contributing any larger donation. No member shall be subject to any other or further assessment.

BOARD OF DIRECTORS

The business of this association shall be managed by a Board of three (3) Directors, being by names and addresses as follows:

Said Board is hereby vested with absolute and irrevocable authority to receive donations and to disburse the monies and funds of this association in such manner as they may deem for the best interests of carrying out the objects and purposes of this association. J. Keith Burns is hereby appointed Temporary Chairman to act until the Board may select and appoint a permanent Chairman.

PURPOSES

This association shall have as its prime interest any issue which involves the subject of taxation, employment and business prosperity in the State of Idaho. In view of the apparent enthusiastic public concern and interest which has been generated in the State of Idaho by the issue as to whether or not the Legislature of the State of Idaho shall enact laws which will authorize local option casino type gaming, it shall be the purposes of this association to gather, compile and to distribute among the voters of the State of Idaho factual

and statistical data and information concerning the tax aspect, the full employment potentials, and the business prosperity expectations from the enactment of such legislation in order to enable the voters of the State of Idaho to exercise their right of franchise intelligently and based upon reason rather that upon emotion, bias, or prejudice. Further, it shall be the broad general purposes of this association to support any plan or program which in the opinion of the Directors of this association will best prevent the enactment of any additional massive taxes upon the citizens of the State of Idaho, to do any and all things which will best support and further a plan to develop a vigorous tourist patronage in the State of Idaho and to do any and all things which will best encourage and develop a building construction prosperity in our state to alleviate a threatening business recession, and to relieve our domestic problems of unemployment.

BY-LAWS The Board of Directors of this association shall have full power and authority to adopt, amend, or repeal the By-Laws of this association; provided, however, that such By-Laws shall be in accordance with the laws and statutes of the State of Idaho, and in particular the laws and statutes of the State of Idaho relating to By-Laws of a non-profit cooperative association.

INCORPORATORS The names of the incorporators of this association shall be those persons whose names appear as signers hereof, at least five (5) of whom have executed and acknowledged these articles of association.
