ARTICLES OF INCORPORATION

SECRETARY OF STATE

OF

MIR TESEN, INC.

The undersigned hereby establishes a Corporation pursuant to the Idaho Business Corporation Act, as amended ("the Act"), and adopts the following Articles of Incorporation.

FIRST: The name of the Corporation is MIR TESEN, INC.

SECOND: The Corporation shall have perpetual existence.

THIRD: (a) The purposes for which this Corporation is organized are to transact any and all lawful business for which Corporations may be incorporated under the Act.

- (b) The Corporation shall have and may exercise all of the rights, powers, and privileges now or hereafter conferred upon Corporations organized under the Act and may do everything necessary, suitable or proper to accomplish any of its corporate purposes.
- FOURTH: (a) The aggregate number of shares that the Corporation shall have authority to issue is 1,000,000 shares of common stock without par value.
- (b) Each shareholder of record shall be entitled to one vote for each share of stock outstanding in his name on the books of the Corporation, except that cumulative voting shall be allowed in the election of directors.
- (c) At all meetings of shareholders, a majority of the shares entitled to vote at such meeting, represented in person or by proxy, shall constitute a quorum; and at any meeting at which a quorum is present the affirmative vote of a majority of the shares represented at such meeting and entitled to vote on the subject matter shall be the act of the shareholders, unless the vote of a greater proportion or number is required by (i) the Act; (ii) by any agreement among all of the existing shareholders; (iii) by a resolution adopted by the shareholders; (iv) or by a prior validly adopted resolution of the board of directors.
- (d) No shareholder of the Corporation shall have any pre-emptive rights.

- (e) The Corporation shall have the right to purchase its own shares to the extent of unreserved and unrestricted earned or capital surplus, provided the Corporation is solvent and when such redemption or purchase would not render it insolvent or reduce the net assets below the aggregate amount payable to the holders of shares having prior or equal rights to the assets of the Corporation upon involuntary dissolution.
- (f) The board of directors may from time to time distribute to the shareholders in partial liquidation, out of capital surplus of the Corporation, a portion of its assets, in cash or property, subject to the limitations contained in the Act.

FIFTH: The Corporation shall have the right to indemnify any person to the fullest extent allowed by the Act, except as limited by the By-laws of the Corporation from time to time in effect.

SIXTH: (a) The initial board of directors shall consist of four directors, however, the number of directors may be increased or decreased from time to time as provided in the By-laws but only on the unanimous approval of the directors then in office. The names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and have qualified are:

(b) At all meetings of directors, a majority of the directors shall constitute a quorum; and at any meeting at which a quorum is present the affirmative vote of a majority of the directors present shall be the act of the directors, unless the vote of a greater proportion is required by any agreement among all of the existing shareholders; by the ByLaws; or by a prior validly adopted resolution of the board of directors.

SEVENTH: The address of the initial registered office of the Corporation is 7091 Emerald, Boise, Idaho 83704. The name of the registered agent at such address is John R. Hansen, Jr.

EIGHTH: A director of this Corporation shall not be liable to the Corporation or its stockholders for monetary damages for

breach of fiduciary duty as a director, except this provision shall not eliminate or limit the liability of a director:

- a. For any breach of the director's duty of loyalty to the Corporation or its stockholders.
- b. For acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law.
 - c. Provided for under section 30-1-48, Idaho Code.
- d. For any transaction from which the director derived an improper personal benefit.
