#### ARTICLES OF INCORPORATION

That the undersigned incorporators being of the age of eighteen (18) years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

### ARTICLE I

The name of the Corporation is FIELD DATA SOLUTIONS, INC.

## ARTICLE II

The period of its duration is perpetual.

### ARTICLE III

The purposes for which the Corporation is organized are:

- (a) To engage in the marketing, sales and services of field data recorders, software and related products, and to design, develop and sell, above or with other entities, hardware and software related to the business of field data recording.
- (b) To perform any other business activities necessary or incidental to the foregoing primary business purposes;
- (c) For the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq.

#### ARTICLE IV

The Corporation is authorized to issue one class of shares, in a total amount of 10,000 shares, said shares bearing no par

value. Shares of stock of this Corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of the Corporation, in accordance with the duly adopted By-Laws of this Corporation.

The capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

### ARTICLE V

The address of the initial registered office of the Corporation is 610 South Lincoln, P. O. Box 31, Jerome, Idaho 83338.

The name of the registered agent is DAVID JAMES DEAN.

The names and addresses of the incorporators are as follows

By-Laws shall be adopted by the Board of Directors which shall have the power to make By-Laws and repeal, amend or alter

the By-Laws from time to time as they deem proper for the administration and regulation of the affairs of the Corporation.

### ARTICLE IX

The right is reserved from time to time to amend, alter, or repeal any provision of and to add to these Articles of Incorporation in any manner now or hereafter prescribed or permitted by the laws of the State of Idaho, and the rights of all shareholders are subject to this reservation.
