ARTICLES OF INCORPORATION

of

BURLEY CHAPTER OF THE

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons, of full age, and citizens of the United States and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

I

That the name of the corporation is: BURLEY CHAPTER OF THE SOCIETY FOR THE PRESERVATION AND ENCOURAGEMENT OF BARBER SHOP QUARTET SINGING IN AMERICA, INC.

II

The purposes of the corporation shall be to perpetuate the old American institution, the barbershop quartet, and to promote and encourage vocal harmony and good fellowship among its members; to encourage and promote the education of its members and the public in music appreciation, to initiate, promote and participate in charitable projects and to promote public appreciation of barbershop harmony, together with all allied purposes connected with barbershop quartet organization.

III

The corporation is to have existence for a period of fifty (50) years.

IV

The location and post office address of the registered office of the said corporation is Burley, Cassia County, Idaho.

V

That the rights of all members in Burley Chapter of the Society for the Preservation and Encouragement of Barber Shop Quartet Singing in America, Inc.




