ARTICLES OF INCORPORTAION

The undersigned, acting as incorporators of a corportation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for the above named corporation:

FIRST: The name of the corporation is BOISE TRUCK DISPATCH, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any and all lawful business, including but not limited to the dispatch of trucks and the brokering of truck services, for which corporations may be corporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares.

FIFTH: One class of shares are to be authorized: non-assessable common stock with a par value of One Dollar (\$1.00) per share.
