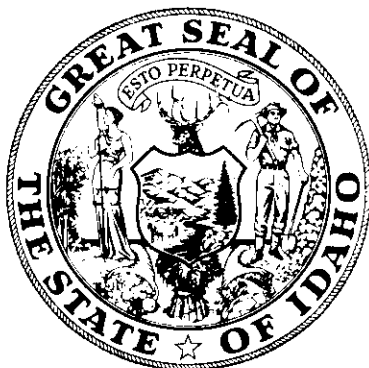

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for the above named corporation:

FIRST: The name of the corporation is BOISE TRUCK DISPATCH, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any and all lawful business, including but not limited to the dispatch of trucks and the brokering of truck services, for which corporations may be incorporated under the Idaho Business Corporation Act.


FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares.

FIFTH: One class of shares are to be authorized: non-assessable common stock with a par value of One Dollar (\$1.00) per share.

SIXTH: The address of the initial registered office of the corporation is 4420 East Overland, Meridian, Idaho 83642, and the name of its initial registered agent at such address is Kayle Hobbs.

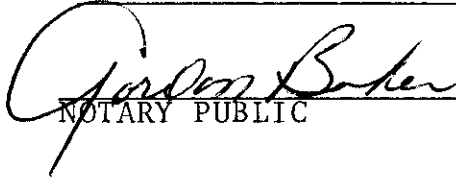
