**PURSUANT TO THE PLAN OF MERGER** effective the 28th day of December, 2016, by and between **SAND HOLLOW SIXTEEN LLC**, an Idaho limited liability company ("**SH16**"), and **LITTLE ENTERPRISES, LLLP**, an Idaho limited liability limited partnership ("**Little Enterprises**"), with SH16 and Little Enterprises being sometimes collectively referenced herein as the "**Parties**" or "**Party**" this Statement of Merger is filed pursuant to Idaho Code § 30-22-205:

**FIRST:** The name of the non-surviving entity upon the Effective Time is SAND HOLLOW SIXTEEN LLC, an Idaho limited liability company ("**SH16**"). Upon the Effective Time, SH16 shall be merged with and into Little Enterprises, and the separate existence of SH16 shall thereupon cease.

**SECOND:** The name of the surviving entity from and after the Effective Time shall be LITTLE ENTERPRISES, LLLP, an Idaho limited liability limited partnership ("**Little Enterprises**"). Little Enterprises shall be the surviving entity.

**THIRD:** The Merger shall become effective on the date and time of filing (the "**Effective Time**").

**FOURTH:** The sole member of SH16 and all general partners of Little Enterprises have approved the Plan of Merger and the merger of SH16 into and with Little Enterprises, upon the terms and conditions contained in the Plan of Merger and subject to the requirements of Idaho law.

**FIFTH:** The Certificate of Limited Partnership and Partnership Agreement of Little Enterprises as in effect on the date hereof shall from and after the Effective Time be, and continue to be, the Certificate of Limited Partnership and Partnership Agreement of the surviving entity until changed or amended as provided by law.

**SEVENTH:** Pursuant to Idaho Code § 30-22-201, this Merger is effected pursuant to the Idaho Model Entity Transactions Act.
