Pursuant to the unanimous consent resolution adopted by the Board of Directors of Home Improvement, Inc., formerly known as Eynon Construction, Inc., and unanimously voted for by RICHARD E. EYNON and TERI L. EYNON, who own the entire 500 shares of issued stock of the corporation, the corporation having only having issued 500 shares of one class of common stock, the corporation's Articles of Incorporation are hereby restated, with the following paragraphs from the corporation's Articles of Incorporation being amended as follows:
