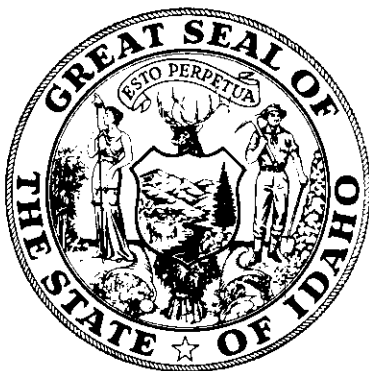

WHEREAS, the sole stockholder and director of Renegade USA, Inc. desires to amend the articles of incorporation of said corporation to alter the capital structure of the corporation.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 10,000 at no par value.
