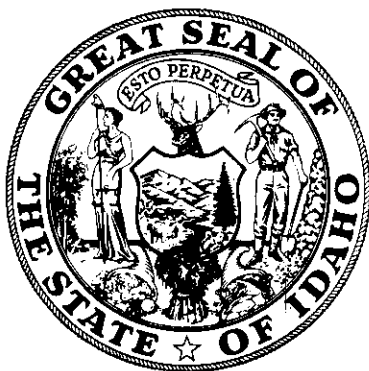

ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF
WILLIAM A. POGUE, M.D., CHARTERED

Pursuant to the provisions of section 30-1312, Idaho Code,
and section 30-1-61 of the Idaho Business Corporation Act,
the undersigned corporation adopts the following Articles of
Amendment to the Articles of Incorporation:

FIRST: The name of this corporation is William A.
Pogue, M.D., Chartered.

SECOND: The following amendments to the Articles of
Incorporation were adopted by the shareholders of the corporation
on July 1, 1989, in the manner prescribed by the Idaho Business
Corporation Act:

Article 1 is hereby amended to read as follows:

1. The name of this corporation shall be Fairview Medical
Clinic, P.A.

Article 5 is hereby amended to read as follows:

5. The address of the initial registered office of this
corporation is 4809 Fairview Avenue, Boise, Idaho 83706, and
the name of the initial registered agent at such address is
William A. Pogue, M.D.

Article 6 is hereby amended to read as follows:

6. The Board of Directors shall consist of two (2)
directors, but during their term of office, or thereafter, the
number of directors may be increased or decreased from time to
time as may be provided by the Bylaws; provided, however, that

the number of directors constituting a Board shall not be less than one (1) or more than five (5).

The following persons are named directors of the corporation to serve until their successors are elected and qualified:

Article 7 is hereby amended to read as follows:

7. All or any meetings of the shareholders, or of the Board of Directors, may be held within or without the state of Idaho.

Article 8 is hereby amended to read as follows:

8. Each shareholder of this corporation shall, because of his ownership of stock, have a preemptive or other right to purchase, subscribe for, or take any part of any stock or any part of the notes, debentures, bonds, or other securities convertible into or carrying options or warranties to purchase stock of this corporation issued, optioned, or sold by it after its incorporation.

The remaining articles shall remain unchanged.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 200; and the number of shares entitled to vote thereon was 200.

FOURTH: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was zero.
