ARTICLES OF INCORPORATION

OF

A & C BEAN, INC.

The undersigned, acting as an incorporator of a corporation, under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for corporation:

- The name of the corporation is A & C BEAN, 1. NAME: INC.
 - 2. DURATION: The period of its duration is perpetual.
- 3. PURPOSE: The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. Additionally the corporation is organized to carry on an agricultural warehousing business and to enter into joint ventures from time to time with any other person, firm, corporation, or entity.
- 4. CAPITAL: The aggregate number of shares which the corporation shall have authority to issue is 2,000 shares, all of which shall be without par value. All stock shall be voting stock.
- 5. PRE-EMPTIVE RIGHTS: There are no provisions denying pre-emptive rights.
- 6. INTERNAL AFFAIRS: No contract or other transaction between the corporation or any other corporation, whether or not a majority of the shares of capital stock of such other corporation is owned by the corporation, and no act of the corporation shall be in any way affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in or are directors or officers of such other corpora-Any director individually may be a party to or may be pecuniarily or otherwise interested in a contract or transaction of the corporation and any directors of the corporation who are

so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize such contract or transaction and may vote thereon to authorize such contract or transaction with the same right, force and effect as if he were not such director or officer of such corporation and not so interested therein. The same shall apply if any officer or director of this corporation shall be interested in any other form of business entity dealing with this corporation.
