The undersigned, acting to incorporate a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME:** The name of the corporation is K D Medical, Inc.

2. **DURATION:** The period of its duration is perpetual.

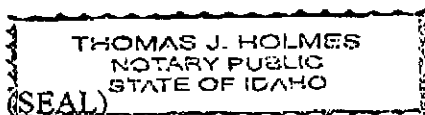
