We, Wallis B. Dunckel and Robert H. Brome, being respectively the President and the Secretary of Bankers Trust Company, do hereby certify:

- 1. The name of the corporation is BANKERS TRUST COMPANY.
- 2. The organization certificate of said corporation was filed in the office of the Superintendent of Banks on the 5th day of March, 1903, and in the office of the County Clerk of New York County on the 5th day of March, 1903.
- 3. The organization certificate as heretofore amended is hereby amended to effect the following changes authorized in subdivision two of section thirty-five of the Stock Corporation Law, to wit: (1) to authorize new shares with par value, and (2) to increase the amount of the authorized capital stock in conformity with the change of the number of the authorized shares.
- 4. The provisions of the organization certificate as heretofore amended with reference to the capital stock and the shares which the corporation is authorized to have and which provide that the amount of its authorized capital stock shall be Eighty-four Million Six Hundred Thousand Dollars

(\$84,600,000), divided into eight million four hundred sixty thousand (8,460,000) shares of the par value of Ten Dollars (\$10) each and which also provide that the amount of its capital stock outstanding is Eighty Million Seven Hundred Seventy-nine Thousand Dollars (\$80,779,000), divided into eight million seventy-seven thousand nine hundred (8,077,900) shares of the par value of Ten Dollars (\$10) each, are hereby amended to read as follows:

"The amount of authorized capital stock which the corporation is hereafter to have is Ninety-three Million Five Hundred Seventy-five Thousand Four Hundred Forty Dollars (\$93,575,440), divided into nine million three hundred fifty-seven thousand five hundred forty-four (9,357,544) shares, all of which are to be, as heretofore, of the same class and of the par value of Ten Dollars (\$10) each. The amount of the capital stock outstanding, giving effect to the issuance of eight hundred ninety-seven thousand five hundred forty-four (897,544) shares as a stock dividend, is Eighty-nine Million Seven Hundred Fifty-four Thousand Four Hundred Forty Dollars (\$89,754,440), divided into eight million nine hundred seventy-five thousand four hundred forty-four (8,975,444) shares of the par value of Ten Dollars (\$10) each."
