ARTICLES OF AMENDMENT TO THE ARTICLES OF IN-CORPORATION OF NORTH RIGBY CANAL COMPANY,

LIMITED

We, the undersigned, president and secretary of the North Rigby Canal Company, Limited, a corporation organized and existing under the laws of the State of Idaho, and having its principal place of business at Rigby, Jefferson County, State of Idaho, hereby certify:

That at a meeting of the stockholders of said corporation duly called for that purpose and held at Rigby, in the County of Jefferson, in said state, on the 3rd day of March, 1952, it was unanimously voted by the holders of all of the outstanding capital stock to amend its Articles of Incorporation in the following respects:

- 1. That the first article be amended to read as follows: That the name of said Corporation is NORTH RIGBY IRRIGATION AND CANAL COMPANY, INC.
- 2. That the fourth article be amended to read as follows: FOURTH. That the term for which it is to exist is perpetual.
- 3. That the sixth article be amended to read as follows:

SIXTH. That the amount of the capital stock of this corporation shall be Two Thousand Five Hundred Dollars, divided into Two Hundred Fifty shares, of the par value of Ten Dollars each.
