4	(A Professional Corporation)
5	I, the undersigned, a natural person over the age of
6	eighteen years do hereby form a professional corporation under
7	the laws of the State of Idaho, as contained in Chapter 13 of
8	Title 30 of the <u>Idaho</u> <u>Code</u> , entitled "Professional Service
9	Corporation Act," and to that end do hereby certify:
10	ARTICLE I
11	NAME
12	The name of the corporation shall be RANDALL J.
13	SLICKERS, M.D., P.A.
14	ARTICLE II
15	PURPOSES AND POWERS
16	The purposes for which the corporation is organized
17	are:
18	A. To engage generally in the professional practice
19	of medicine as a professional corporation as the same is now or
20	hereafter defined by statute, rule and regulation;
21	B. To invest funds in real property, personal pro-
22	perty, mortgages, stocks, bonds or any other type of invest-
23	ments and to own or lease real or personal property necessary
24	for the rendering of such professional services;

	c. To engage in such other businesses or professions
2	as may be authorized or permitted by the Professional Service
3	Corporation Act (Chapter 13 of Title 30 of the Idaho Code) and
4	to the extent not inconsistent with the foregoing as may be
5	permitted by the Idaho Business Corporation Act (Chapter 1 of
6	Title 30 of the Idaho Code).
7	ARTICLE III
8	DURATION
9	The period of duration of the corporation shall be
10	perpetual.
11	ARTICLE IV
12	REGISTERED OFFICE
13	The registered office of said corporation in the
14	State of Idaho shall be located at 560 Shoup Avenue West, Twin
15	Falls, Twin Falls County, Idaho; the post office address of the
16	registered office of said corporation in the State of Idaho,
17	County of Twin Falls, shall be 560 Shoup Avenue West, Twin
18	Falls, Idaho. Randall J. Slickers, M.D., shall be the regis-
19	tered agent at the address set forth above.
20	ARTICLE V
21	CORPORATE STOCK
22	The aggregate number of shares which the corporation
23	shall have authority to issue is 5,000, all of which shall have
24	a par value of \$1.00 per share.

7	ARTICLE VII
8	MANAGEMENT
9	The business of the corporation shall be managed by a
10	board of at least three (3) directors, except that if all of
11	the shares of the corporation are owned beneficially and of
12	record by either one (1) or two (2) stockholders, the number of
13	directors may be less than three (3) but not less than the
14	number of stockholders. Directors need not be shareholders. A
15	director shall hold office for the term for which he was named
16	or elected and until his successor is elected and qualified.
17	There shall be one (1) director on the initial Board
18	and he shall be Randall J. Slickers, M.D., who shall serve as a
19	director until his successor is elected and qualified.
20	ARTICLE VIII
21	BY-LAWS
22	The power to adopt, repeal and amend the By-Laws of
23	the corporation shall be in the stockholder and the By-Laws may
24	be amended, adopted or repealed by the stockholder.
