KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all of whom are residents of the State of Idaho, have this day volunterily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho.

AND WE DO HEREBY CERTIFY IN URITING:

I. The name of the said corporation shall be ${\tt EAST}$ SIDE CABINET CO.

II. That the purposes for which the said Corporation is formed are:

- A.To buy and sell material pertaining to debinet work.
- B.To buy and sell all building material.
- C.To purchase, acquire, own, hold, lease, sell, assign, transfer, mortgage, or otherwise dispose of, and to invest, trade and deal in and with real property, and any and all interests therein.
- D.To sublet, rent, or hire any of its property for any legitimate purpose or undertaking.
- E.To build and contruct houses or other buildings of every kind and character, either for sale or lease or on contract or otherwise.
- F.To borrow money, to issue bonds, for any of the objects or purposes of this Corporation, and to mortgage, pledge, any or all of its property to secure the payment thereof.
- G.To enter into, make, perform, and carry out constructions of every kind and for any lawful purpose, without limit as to the amount, with any person, firm, association, corporation, municipality, state, or government, or any subdivision, district or department thereof.

III. That the location of the office and the Post Office address of the said office at Idaho shall be Idaho Falls, Idaho.

IV. That the term for which the seid Corporation is to exist is for fifty (50) years.

V. That the number of directors of the said Corporation at the time of its organization shall be three (3), but increased at any annual meeting of the stockholders, enough to exceed seven (7) in number.

VI. That the total number of shares that the said Corporation shall have shall be sixty (60), at a par value of One Hundred (\$100.00) Dollars each, and a total aggregate sale value of (\$6000)Six Thousand Dollars.

VII. That all the stock of the said Corporation shall be common stock with equal voting power, rights, preferences, and restrictions.
