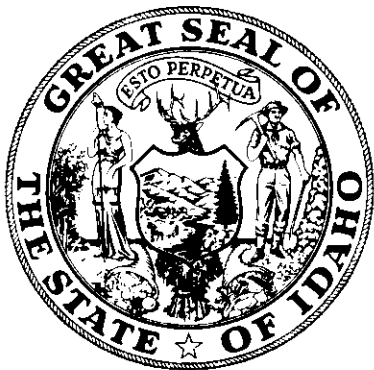

SECOND ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
THE IDAHO FALLS YOUTH HOCKEY ASSOCIATION, INC.

Pursuant to the provisions of Section 30-1-61 of the Business Corporation Act, the undersigned corporation adopts the following Second Articles of Amendment to its Articles of Incorporation:

FIRST: The following amendment consisting of an addition to the third Article of the original Articles of Incorporation was adopted by the members of the corporation on December 21, 1982, in the manner prescribed by the Idaho Business Corporation Act.

"This corporation is organized exclusively for charitable or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code."

"Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code."


SECOND: The amendment makes no change in the amount of stated capital, nor of the class, or cancellation of any membership certificates.
