ARTICLES OF AMENDMENT TO THE

ARTICLES OF INCORPORATION

OF

STE. CHAPELLE, INC.

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is STE. CHAPELLE, INC.

SECOND: The following amendment of the Articles of Incorporation were adopted by the shareholders of the corporation on April 25, 1986, in the manner prescribed by the Idaho Business Corporation Act:

That Article V of the Articles of Incorporation of Ste. Chapelle, Inc., be amended to read as follows:

*ARTICLE V

Stock

This corporation is authorized to issue one class of shares of its capital stock to be designated as common stock; the total number of shares of common stock which this corporation shall be authorized to issue is 5,000,000. The aggregate par value of the capital stock of this corporation shall be \$5,000,000.00; and the par value of each of said shares of common stock shall be \$1.00."

The number of shares of the corporation THIRD: outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.

FOURTH: The number of shares voted for such amendment was 800; that there were no shares voting against said amendment, but that 200 shares abstained from voting either for or against said amendment.

FIFTH: The manner in which such amendment effects a change in the amount of stated capital, and the amount of stated capital as changed by such amendment, are as follows:

The stated stock is to remain as common capital stock with the continuing par value of \$1.00 per share, making the amount of stated capital in the sum of \$5,000,000.
