ARTICLES OF AMENDMENT
OF

MODULEX CORPORATION a corporation organized, acting, and existing under and by virtue of the laws of the State of Idaho, by its shareholders, hereby amends its Articles of Incorporation, heretofore filed in the office of the Secretary of State of the State of Idaho, by amending and changing Article 1 of its said Articles of Incorporation, reading as follows, to-wit:

"The name of the proposed corporation is MODULEX CORPORATION to be changed as follows:

The name of the corporation is "SHELTEREX CORPORATION".

That the aforementioned amendment to its said Articles of Incorporation was duly and regularly adopted at a meeting of the shareholders of the corporation duly called and held for such purpose on the 22nd day of December, 1970, said notice for such meeting being given on the 20th day of November, 1970.
