Forney, resident at Moscow, in said Latah County, as the authorized agent of said corporation in said State of Idaho, upon whom process issued by authority of or under any law of the State of Idaho may be served, as provided by the constitution and laws of said State of Idaho, and the said The Alliance Trust Company, Limited, desiring and intending to conform in all respects to the constitution and laws of said State and to avail itself of the rights, privileges, and the immunities decreed by said constitution and laws, does hereby accept the provisions of the constitution of the State of Idaho for all the intents and purposes contemplated by the provisions thereof, regarding such acceptance by other than municipal corporations. (Article XI, Section 7, Constitution of Idaho).

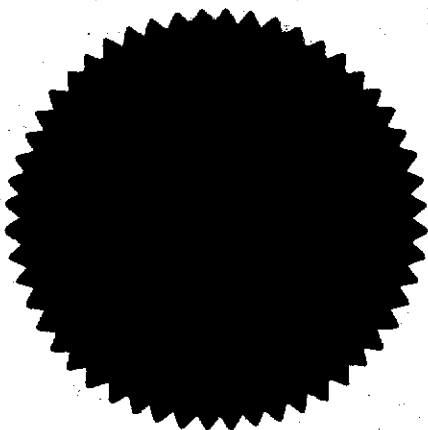
