





FIRST: The name of the corporation is:

CINDY'S JEROME CORPORATION.

SECOND: The corporation's purposes are:

- (a) To engage primarily in the specific business of restaurant ownership and operation;
- (b) To engage generally in the business of purchasing, developing and operating restaurants;
- (c) To engage in any business, whether related or unrelated to those described in clauses (a) and (b) of this article, that may from time to time be authorized or approved by the board of directors of this corporation;
- (d) To act as a partner or a joint venturer or in any other legal capacity whenever deemed advisable by the board of directors;
 - (e) To do business anywhere in the world;
- (f) To have and to exercise all the rights and powers that are now or may hereafter be granted to a corporation by law;
- (g) To establish and carry out, alter, or amend such systems, plans, or trusts for providing pensions for employees, officers and directors of the corporation as the board of directors may determine and so as to be a business expense of the corporation, with or without contributions from the beneficiaries; and
- (h) To provide, alter, or amend such methods or plans for employees, officers and fix directors to participate in the profits of the corporation as the board of directors may determine, including stock purchase plans with restricted stock options.

The above purpose clauses are not limited by reference to or inference from one another. Each clause is to be construed as a separate statement conferring independent purposes and powers on the corporation.

THIRD: The county in the State of California where the principal office for the transaction of the business of this corporation is to be located is Santa Clara County.

<u>FOURTH:</u> (a) The number of directors of this corporation shall be three (3).
