ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, this day voluntarily associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and for that purpose, we hereby certify:

FIRST. That the name of said corporation is "ALBION MERCANTILE COMPANY, LIMITED."

SECOND. That the purposes for which it is formed, are to purchase, acquire, and take over the business and property, both real and personal, and assets of every nature and description of the business now being carried on by Louis Solomon in Albion, Cassia County, Idaho; and of the business now being carried on by Charles O. Dumas in Albion, County of Cassia, State of Idaho; to carry on a general wholesale and retail business in goods, wares and merchandise of all kinds and nature whatsoever, and to do and transact everything necessary, proper and beneficial in carrying out any of the foregoing named objects, and also to acquire, sell, lease, rent, hire and hypothecate real estate and to make assignments of leases and contracts and to transfer and assign leases and contracts when and where necessary and incident to said business.

THIRD. That the place where its principal business is to be transacted, shall be the town of Albion, Cassia County, State of Idaho.

FOURTH. That the term for which it is to exist, is fifty years from and after the date of its incorporation.

FIFTH. That the number of its directors shall be five.

SIXTH. That the amount of capital stock of this corporation shall be Twenty Thousand (20,000) Dollars, divided into four hundred (400) shares, of the par value of Fifty (50) Dollars, each.

SEVENTH. That the amount of said capital stock which has been actually subscribed, is Twelve Thousand (12,000) Dollars, and the following are the names of the persons by whom the same has been subscribed:
