Article 1: The name of the corporation is....Cream Ridge Church of the United Brethren  
In Christ, Inc.

Article 2: The purpose for which the corporation is organized is:

- A. To propagate the Gospel of the Lord Jesus Christ and to instruct the saints to worship the Lord in spirit and in truth ;
- B. To establish and maintain a church and to provide a place of worship in Clearwater County of the State of Idaho;
- C. To establish, maintain, and conduct schools for the religious instruction of the young and to further other religious work;
- D. To purchase, lease, exchange, or otherwise acquire, own, hold, develop, Operate, manage, sell, assign, build upon, transfer, convey, mortgage, deed in trust, or otherwise dispose of any real and personal property of every class and description;
- E. To borrow or raise monies for any of the purposes of this corporation;
- F. 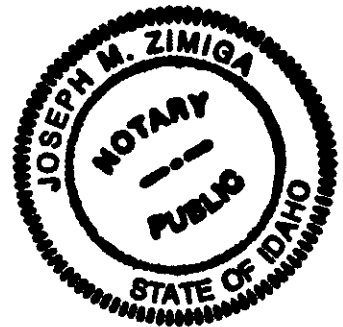
